

## 2014 NACDL White Collar Criminal Defense College at Stetson - March 19 - 22, 2014




### Brothers and Sisters:

As a follow-up to our Round Table discussion of Michael Morton's experient last year in Colorado Springs, I wanted to let you know that yesterday Judge Ken Anderson (Michael's prosecutor) was found guilty of criminal contempt, sentenced to jail and disbarred for hiding critical evidence at Michael's trial. I've attached the predictable, self-serving photo and article.

One often wonders what would be a truly just result. My retributive sense is that Anderson should serve out the remainder of Michael's life sentence. But, the strong and powerful message here was not only that Anderson was pronounced guilty, will go to jail and will be disbarred (a first), but more importantly, the DA in Williamson County has agreed to an outside, transparent audit of all cases Ken Anderson prosecuted and that his successor, John Bradley refused to conduct DNA testing (you may recall that he fought against DNA analysis in Michael's case for 7 years), to be conducted by the Texas Criminal Defense Lawyers Association and the Innocence Project. Anderson's plea deal only protects him against matters arising out of Michael's case. Anyway, it was very satisfying day. Best to all, Jerry Goldstein

## Judge declares mistrial in sexual assault case against celebrated Beck Center actor Kevin Joseph Kelly

CLEVELAND, Ohio -- The curtain came down on the explosive real life drama unfolding in Judge Deena Calabrese's courtroom Friday when she declared a mistrial in the sex abuse prosecution of celebrated local actor Kevin Joseph Kelly.

Since his indictment in January, 2012, Kelly, 56, has vociferously denied accusations that he assaulted two teens in separate incidents in his Lakewood apartment 17 years ago. At issue is a piece of new evidence, a handwritten statement given to Lakewood police by one of the alleged victims, now 32 and a respected area performer and voice teacher.

The morning's proceedings were marked by emotional testimony from the man, who often broke down sobbing as he described being drunk on Wild Turkey at Kelly's apartment following a cast party in 1996, then winding up in Kelly's bed, where he claims Kelly performed oral sex on him.

As a teenager, he said he looked up to Kelly, called "the life of the party" and incredibly charismatic by a host of prosecution witnesses who took the stand this week.

The man, who walked into the Lakewood police department in 2011 to file a report, told defense attorney <a href="Lan Friedman">Ian Friedman</a> during cross examination that he had given police a handwritten statement at the time detailing the alleged assault.

"When you did your report . . . what I'm asking you is, did you write one in your own haridwriting? Friedman asked.

"I did," the man replied.

"Are you positive of that?" Friedman pressed.

"Positive," the witness said.

The man further stated that Assistant Cuyahoga County Prosecutor Mary Weston had shown him the document to review prior to trial. But Kelly's defense team didn't have that same opportunity because they never received that document from prosecutors, as is required by rules of discovery. "We should have had that two years ago," Friedman said following Calabrese's ruling.

"The state produced a key piece of evidence in the middle of trial warranting a mistrial. Although unfortunate, we will get prepared to defend him again." Prosecutors were asked for, but did not offer any, comment.

After excusing the jury, Judge Calabrese told Kelly and the gathered lawyers that she hoped to reschedule the case early in the new year. A pretrial hearing has been set for Dec. 17.

"There is certainly a lot of disappointment that this matter could not be brought to conclusion after nearly two years of litigation," Friedman said. "Nothing has changed for us, Kevin still maintains his innocence and we will proceed as we have to."

Kelly, known for starring roles in "Hairspray" and "La Cage aux Folles" at Lakewood's Beck Center for the Arts, faces charges including rape, sexual battery, kidnapping and unlawful sexual conduct with a minor.

To the extent one cares about one's death making a news splash, it's best as a rule not to expire on the same day, or nearly the same day, as a Kennedy. Such was the case with the author Dominick Dunne, who died in 2009 the day after Senator Edward M. Kennedy. Dunne's family initially refused to confirm his death, concerned that the transact of coverage on Kennedy's would swamp Dunne's obtinary.

A somewhat different type of piguancy came into play in 1895 when King George V's dector injected him with a fatal does of morphige and cocaine in order that his death could be announced (according to his notes) "in the morning papers rather than the less appropriate

evening journals."

It's a tempting cliché to look back at almost any given year in history and whistle, "That was the year that was." Still, consider what transpired in 1963: Sylvia Plath committed suicide. April saw the worst submorine disaster in history, when the U.S.S. Thresher sank off Cape Cod with all 129 hands. In June, Medgar Evers of the N.A.A.C.P. was murdered in Jackson, Miss., after President Kennedy gave a televised speech on civil rights. The much-beloved Pope John XXIII died. The president of South Vietnam, Ngo Dinh Diem, was ousted in a coup by his generals and murdered. President Kennedy had given his tacit approval to Diem's removal. What exact impact Diem's death had on the war and the deaths of more than \$8,000 United States troops will be an endless subject of debate. Three weeks later, Kennedy went to Dallas, where, according to the original script of "Dr. Strangelove," a good time could be had, provided you had the right kit.
